## Villages of Garrison Creek Annual Meeting January 15, 2012 Dethman Memorial Building, College Place, WA

Meeting was called to order at 2pm with a quorum established.

Officers Present: Don Coleman, President; Joyce Beecroft; Doug Botimer, Developer Rep; Allan Fisher, Developer Rep and Secretary/Treasurer.

Quorum required: 75; Present in person or by proxy: 135.

Present in person or by proxy with eligibility to vote: 110 of 203 eligible votes.

- 1. New agenda's distributed with corrected date -Unanimously accepted.
- 2. Minutes from 2011 Annual Meeting Unanimously accepted.
- 3. Financials for 2011 Unanimously accepted.
- 4. After amendment, a motion by Don Coleman to protect our nonprofit organization status "Be it resolved by the owners of the Villages of Garrison Creek that the amount by which each member's assessments in 2011 exceeds the total payments of the MPMA for maintenance, repairs, capital expenditures, and other expenses of the MPMA, as the Board of Directors has appropriately paid or determined payable, shall be applied to the 2012 regular member assessments." --will be given notice to members of the Homeowners Association and call for a vote with appropriate length of time specified within the bylaws. Approve this vote by either paper ballot or email. Quorum will be established at 75 votes, in order to pass, a majority of votes cast would be required. Unanimously accepted.
- 5. A motion was introduced by Roger Williams, to accept the proposed 2012 budget. John Cress amended the main motion as follows: "Move that we amend the line item for the ARC to the 2010 actual total of \$3845.17". A floor vote was taken and the amendment failed (56 opposed, 53 in favor).
- 6. Then, before the main motion was voted on, John Cress made another amendment to the motion as follows: "Move that we amend the main motion to say that with the exception of the one line item relating to the ARC, we approve the 2012 Budget and send for consideration by the association members the recommendation that the ARC be funded at the level actually spent in 2010." A floor vote was taken and the amended main motion was passed by the members present (68 in favor, 47 opposed). The clear intent of John's motion was to limit the ARC funding in 2012 to that stated in his first amendment \$3845.17.
