Special notes: John Jaso, new member of the Association, has a drone and is volunteering to photograph the Villages, especially the pond areas, to map out the trees and shrubs. Jim Murphy announced that Roger Willams would no longer be able to mow the area south of the creek. Ray Goff has taken on some of the mowing but cannot continue. Jim suggested that we incorporate some mowing expenses in the 2019 Budget. Connie Fisher noted that the grass that was planted in the meadow was the kind that only grows 10 inches high and we should not have to mow as often as we have. That area should be allowed to have taller grass to protect the small animals that live there.

1.. Quorum Call: There was no quorum as both Declarant Board Members must be present. Doug Botimer was excused from the meeting at his request since there were no action items. John Cress was absent.
